

Exercise 1.1

a.
$$N_5(t) = N_3(t-1) \text{ OR } N_4(t-1)$$

 $N_3(t-1) = N_1(t-2) \text{ AND } N_2(t-2)$
 $N_4(t-1) = N_1(t-2) \text{ AND NOT } N_2(t-2)$


so

$$N_5(t) = [N_1(t-2) \text{ AND } N_2(t-2)] \text{ OR } [N_1(t-2) \text{ AND NOT } N_2(t-2)]$$
 (Note that this reduces to $N_5(t) = N_1(t-2)$.)

Both this net and the net in Figure 1.17 involve 1 hidden layer of 2 units; this net uses 3 different basic neuron types, the net in Figure 1.17 uses only 2.

Exercise 1.3

The modified requirements can be expressed as

$$y_2(t) = \{x_2(t-3) \text{ AND } x_2(t-2)\} \text{ AND } x_2(t-1).$$

The requirement for y_1 remains unchanged:

$$y_1(t) = x_1(t-1) \text{ OR } \{x_2(t-3) \text{ AND NOT } x_2(t-2)\}.$$


The network is modified by the addition of a hidden unit, W, such that

$$w(t) = z_2(t-1) \text{ AND } x_2(t-1)$$

= $x_2(t-2) \text{ AND } x_2(t-1)$

so that

$$y_2(t) = w(t-1) \text{ AND } x_2(t-1).$$



Exercise 1.4


If heat is applied, heat will be perceived one time step later and will continue to be perceived until one time step after the heat is removed.

If cold is applied for one time step and removed, heat will be perceived two time steps later, but only for one time step.

If cold is applied for two or more steps, cold will be perceived two time steps after the application. This perception of cold will continue until one time step after the cold is removed. Heat will then be perceived for one time step (i.e. two time steps after the cold stimulus is removed).

Exercise 1.5

A simple network to recognize an "upscale" when the sequence DO, RE, MI is input and to recognize "downscale" when MI, RE, DO is input is shown below.




The analysis for the upscale portion of the net is as follows; the downscale portion is similar.

The desired response is

$$UP(t)$$
 = $MI(t-1)$ AND [RE(t-2) AND DO(t-3)]
 = $MI(t-1)$ AND B1(t-1)
 B1(t-1) = RE(t-2) AND A1(t-2)
 A1(t-2) = DO(t-3)

Note that this network does not require "clean playing" of the scale segment; for example, further refinements could require that RE(t-1), DO(t-2), and DO(t-1) be 0 (in addition to MI(t-1), RE(t-2), and DO(t-3) being 1) for the upscale neuron to give a positive response.

Note that at each stage of learning the separating line is exactly the same as for the case with $\alpha = 1$.

b. If the response of the net is incorrect for a given training input, the weights are updated according to $\widetilde{w}(\text{new}) = \widetilde{w}(\text{old}) + \alpha \, \widetilde{x}$. We now show that the sequence of input training vectors for which a weight change occurs is finite. If $\widetilde{x}(0)$ is the first training vector for which an error occurred, then $\widetilde{w}(1) = \widetilde{w}(0) + \alpha \, \widetilde{x}(0)$ (where by assumption $\widetilde{x}(0) \cdot \widetilde{w}(0) \leq 0$).

If another error occurs, we denote the vector $\tilde{\mathbf{x}}(1)$.

$$\widetilde{\mathbf{w}}(2) = \widetilde{\mathbf{w}}(1) + \alpha \widetilde{\mathbf{x}}(1)$$
 (where by assumption $\widetilde{\mathbf{x}}(1) \cdot \widetilde{\mathbf{w}}(1) \le 0$), etc.

Combining the successive weight changes gives

$$\widetilde{\mathbf{w}}(\mathbf{k}) = \widetilde{\mathbf{w}}(0) + \alpha \widetilde{\mathbf{x}}(0) + \alpha \widetilde{\mathbf{x}}(1) + \alpha \widetilde{\mathbf{x}}(2) + \dots + \alpha \widetilde{\mathbf{x}}(\mathbf{k}-1)$$

We now show that k cannot be arbitrarily large.

Let \widetilde{w} * be a weight vector such that $\widetilde{x} \cdot \widetilde{w}$ * > 0 for all training vectors in F. By assumption such a weight vector exists! Let $m = \min\{\widetilde{x} \cdot \widetilde{w}^*\}$ where the minimum is taken over

all training vectors in F; this minimum exists as long as there are only finitely many training vectors. Now

$$\begin{split} \widetilde{w}(k) \cdot \widetilde{w} \, * & = & \left[\widetilde{w}(0) + \alpha \ \widetilde{x}(0) + \alpha \ \widetilde{x}(1) + \alpha \ \widetilde{x}(2) \right] \dots + \alpha \ \widetilde{x}(k-1) \right] \cdot \widetilde{w} \, * \\ & \geq & \widetilde{w}(0) \cdot \widetilde{w} \, * + k \alpha \, m \\ & \quad \text{since} \ \ \widetilde{x}(i) \cdot \widetilde{w} \, * \geq m \text{ for each } i, \, 1 \leq i \leq P. \end{split}$$

By the Cauchy-Schwartz inequality

$$\|\widetilde{\mathbf{w}}(\mathbf{k})\|^2 \qquad \geq \qquad \frac{(\ \widetilde{\mathbf{w}}(\mathbf{k})\boldsymbol{\cdot}\widetilde{\mathbf{w}}^*\)^2}{\|\widetilde{\mathbf{w}}^*\|^2} \qquad \geq \qquad \frac{(\widetilde{\mathbf{w}}(0)\boldsymbol{\cdot}\widetilde{\mathbf{w}}^* + \mathbf{k}\ \alpha\ \mathbf{m}\)^2}{\|\widetilde{\mathbf{w}}^*\|^2}\ .$$

This shows that the squared length of the weight vector grows faster than k² where k is the number of time the weights have changed.

However, to show that the length cannot continue to grow indefinitely, consider

$$\widetilde{\mathbf{w}}(\mathbf{k}) = \widetilde{\mathbf{w}}(\mathbf{k}-1) + \alpha \widetilde{\mathbf{x}}(\mathbf{k}-1)$$
,

together with the fact that

$$\tilde{x}(k-1) \cdot \tilde{w}(k-1) \leq 0.$$

By simple algebra

$$\begin{split} \parallel \widetilde{\mathbf{w}}(\mathbf{k}) \parallel^2 &= \quad \parallel \widetilde{\mathbf{w}}(\mathbf{k}\text{-}1) \parallel^2 + 2\alpha \ \widetilde{\mathbf{x}}(\mathbf{k}\text{-}1) \boldsymbol{\cdot} \widetilde{\mathbf{w}}(\mathbf{k}\text{-}1) + \alpha^2 \parallel \widetilde{\mathbf{x}}(\mathbf{k}\text{-}1) \parallel^2 \\ &\leq \quad \parallel \widetilde{\mathbf{w}}(\mathbf{k}\text{-}1) \parallel^2 + \alpha^2 \parallel \widetilde{\mathbf{x}}(\mathbf{k}\text{-}1) \parallel^2 \end{split}$$

Now let $M = \max \{ \| \tilde{x} \|^2 \text{ for all } x \text{ in the training set} \}$; then

$$\begin{split} \parallel \widetilde{w}(k) \parallel^2 & \leq \qquad \parallel \widetilde{w}(k\text{-}1) \parallel^2 + \alpha^2 \parallel \widetilde{x}(k\text{-}1) \parallel^2 \\ & \leq \qquad \parallel \widetilde{w}(k\text{-}2) \parallel^2 + \alpha^2 \parallel \widetilde{x}(k\text{-}2) \parallel^2 + \alpha^2 \parallel \widetilde{x}(k\text{-}1) \parallel^2 \\ & \cdots \\ & \leq \qquad \parallel \widetilde{w}(0) \parallel^2 + \alpha^2 \parallel \widetilde{x}(0) \parallel^2 + \cdots + \alpha^2 \parallel \widetilde{x}(k\text{-}1) \parallel^2 \\ & \leq \qquad \parallel \widetilde{w}(0) \parallel^2 + k \alpha^2 M \; . \end{split}$$

Thus the squared length grows less rapidly than linearly in k.

Combining these two inequalities shows that the number of times that the weights may change is bounded. Specifically,

$$\frac{(\widetilde{\mathbf{w}}(0)\boldsymbol{\cdot}\widetilde{\mathbf{w}}^* + \mathbf{k} \ \alpha \ \mathbf{m})^2}{||\ \widetilde{\mathbf{w}}^*||^2} \qquad \leq \qquad \|\ \widetilde{\mathbf{w}}(\mathbf{k})\ \|^2 \qquad \leq \qquad \|\ \widetilde{\mathbf{w}}(0)\ \|^2 + \mathbf{k} \ \alpha^2 \ \mathbf{M}$$

Again, to simplify the algebra, assume (without loss of generality) that $\tilde{w}(0) = 0$. The maximum possible number of times the weights may change is then given by

$$\frac{(\mathbf{k} \alpha \mathbf{m})^2}{\|\widetilde{\mathbf{w}}^*\|^2} \leq \mathbf{k} \alpha^2 \mathbf{M}$$
